Policy on enrollment requirement for graduation, Jim Fabisiak and Mike Dolinger

Dr. Jim Fabisiak reiterated the policy, discussed at the December 2021 EPCC meeting, related to the requirement that Pitt Public Health students must register for a credit in their term of graduation. This is because a faculty member with a student affected by this policy had reached out to him. As decided in the December 2021 meeting, the school will keep the policy as-is and will allow an appeals process on a case-by-case basis.

Mike Dolinger provided a recent example of an exception who did not have to register for a credit to finish their thesis, which was approved by this student's ETD advisor and Dr. Jessica Burke. He also mentioned that this policy affected a lot of students in June 2021 due to the effect of the COVID-19 pandemic.

<u>ACTION</u>: Committee members decided to reevaluate the list in June 2022 to see if the number of students affected by this policy declines.
