PROFESSIONAL ACTIVITIES

1. Teaching

From 1992 thru 2004, Dr. Kingsley served as primary instructor for IDM 2011, Health Disease and the Environment. This was a core course in the Graduate School of Public Health.

This GSPH Core Course is designed to teach public health students the relationships between infectious disease and community health as well as provide a basic vocabulary of select principles of genetics, infection, disease and immunity. IDM 2011 is a one-credit course, with 14 hours of lecture. Average attendance over the 13 years was 65-100 students. Dr. Kingsley remains as a lecturer in IDM 2011, providing a 2-hour lecture “HIV/AIDS-Lessons Learned”.

During the 2001 academic year Dr. Kingsley, together with Dr. Aurelia Koros began a new GSPH course, “Vaccines in Current Use”. This new course was approved by GSPH EPCC and was given as a one-credit course during Spring 2002 thru Spring 2004. Course content was increased and the credits increased to two. This course was cross-listed with MVSM last academic year. This course is no longer active.

Dr. Kingsley also has classroom teaching responsibilities in the Department of Epidemiology, Graduate School of Public Health. For the past 15 years, 1-2 lecture hours were given in the following:

Dr. Kingsley has been involved in the teaching of the Department of Epidemiology since 1984. Between 1984 and 1996, one lecture and one laboratory exercise has been contributed to Epidemiology 2110, Principles of Epidemiology. A typical lecture was “Long Incubation Period Diseases-AIDS” w/ accompanying laboratory exercise. Two hours of lecture were provided in 2005 for Epidemiology 2110 and done since as needed. Additional lectures were provided in Epidemiology 217, Epidemiology of Select Chronic Diseases. The lecture was “ Understanding Markers of Host Susceptibility”.

Recent teaching contributions include a lecture developed for Public Health 2009, “Critical Issues in Global Health”, provided 2002-2007, and development of a lecture for the new course MSMVM 3435, Tumor Virology, “HIV-associated Malignancies”.
