The complexity of these challenges both in the US and abroad requires a continuing flow of well-trained, committed, and competent health care and public health managers, health policy analysts, public health trained lawyers, and consumer advocates. Each of you has responded to this challenge to be among the next cycle of highly competent and well-prepared public health and health services professionals and leaders. We will do our very best to provide you with access to the resources, expert mentoring, and staff support services that will assist you in making progress toward your own career goals and professional development.

#### **MHA Program**

The primary purpose of the MHA Program is to provide graduate-level education that equips students with relevant and transferable competencies, knowledge, and values required for entry into and advancement within management and leadership roles in the health industry. Upon graduation, students seek professional employment in integrated delivery systems, health plans, physician practices, consulting firms, biotech and medical devices companies, and many other health industry settings.

The MHA curriculum requires 60 credits of full-time study over five academic terms including a Management Residency. The Curriculum consists of a broad array of courses covering the organization of the US health care system, functional areas of management, analytics, health economics, leadership, and professional development activities. The MHA Program also provides the student with opportunities for exposure to the world of practice through our Executive in Residence program, the required Management Residency, matching with a health care professional as a Mentor, and various networking and career development activities.

The Master's Essay is a requirement of the MHA program and the School of Public Health. No MHA student can graduate without successfully completing a Master's Essay. It is an important educational component of the MHA program since the essay provides students an opportunity to integrate the major components of the educational learning experience. Students apply the principles of public health, health administration, and health policy to a formal inquiry and analysis to problems or issues relevant to health administration and their career interests. The essay allows the student to demonstrate their mastery of health policy and management concepts, principles, and theoretical models gained from formal coursework. The student is expected to demonstrate professional-level proficiency in expository writing, clear and logical thinking, and appropriate use of analytical tools and research methods.

The Management Residency is a required one-credit course, usually conducted during the Summer Term (May through August), that provides the student with over 400 hours of practice-based, professional experience. The student is matched with a host healthcare organization, health plan, or other appropriate industry setting under the direction of a preceptor. The preceptor is typically a seasoned health executive or manager who is able to mentor, share their knowledge and insights, and provide access to key executives within the organization. The student is usually given considerable responsibility for multiple projects and exposure to both operational and governance levels of the host organization. Opportunities for an Extended Residency are also available in which the selected student completes the Residency through a mix of full-time work during the summer and part-time work during the school year. The value added of the Management Residency to the student's professional development far exceeds the one credit required for this experience.

#### MHA/MBA Program

The Department initiated a new joint MHA/MBA Program in collaboration with the Joseph P. Katz Graduate School of Business effective Fall Term 2016. This 73-credit, 3-year program provides students with education in the core business management functions supplemented by and aligned with the structures, processes, environmental context, and professional norms and values associated with the health care industry. Students pursuing this competency-based curriculum will have the opportunity for two distinct Residency placements. These supervised placements in a wide variety of health industry settings are an invaluable experience for professional development and networking. The student must also complete a master's essay and an applied management project at the residency site. #### Master of Public Health (MPH) in Health Policy and Management

The MPH degree program in the Department of Health Policy and Management provides advanced education for recent graduates as well as entry-level and mid-career professionals to facilitate their career development as leaders and managers, health professionals, policy analysts, and advocates for various roles and contexts in public health and health care. In addition to the 45-credit, competency-based curriculum, students may complete a 15-credit certificate within the two-year plan of study for the MPH.

The curriculum includes MPH core courses for the School of Public Health, required policy courses for the department, and additional elective courses offered both within and outside the Schools of the Health Sciences.

#### **Practicum Requirement**

In addition to coursework, MPH students are required to complete a 200-hour practicum. Students register for one credit of HPM 2025 (HPM Practicum). Students work with their advisor and practicum preceptor to identify five competencies that will be accomplished during the practicum and two practical non-academic work products (deliverables) to be completed for the benefit of the organization/agency. At least three of the five competencies must be CEPH foundational competencies, and at most two competencies can be discipline-specific competencies for the department. Practicum Learning Agreement forms must be completed within 2 weeks of starting the practicum.

After completing the practicum, MPH students are required to submit an e-portfolio documenting the attainment of competencies and completion of work products. Evaluations of the practicum experience and student's accomplishments are completed by the student and preceptor.

#### **Essay Requirement**

The Master's Essay is a requirement of the MPH program and the School of Public Health. No MPH student can graduate without successfully completing a Master's Essay. The essay provides students with an opportunity to integrate major components of their learning experience. For the Department of HPM, students apply principles of public health, health administration, and health policy to a formal inquiry and analysis of a problem or issue pertaining to health policy and student interests. Students demonstrate mastery of health policy concepts, principles, and theoretical models gained from formal coursework and experiential opportunities. This is achieved through proficiency in expository writing, critical thinking and synthesis, and appropriate use of analytical tools and methods.

At the beginning of their final year, students work with their primary essay advisor to complete an Integrated Learning Experience (ILE) agreement form identifying three competencies to be integrated and synthesized through essay activities, including two CEPH foundational competencies and one discipline-specific competency for the Department of HPM. Upon submission of the essay, students and their advisors complete an ILE final assessment form, verifying integration and synthesis of the competencies in the essay. The final essay must be submitted via D-Scholarship.

#### Juris Doctor / Master of Public Health (JD/MPH) Joint Degree

The MPH portion of the JD/MPH Joint Degree Program is housed within the Department of Health Policy and Management. Offered jointly with School of Law, graduates of this four-year program receive the Juris Doctor (JD) degree and the Master of Public Health (MPH) degree. Current MPH students interested in applying should contact the program director for further information.

#### **Registration by School**

Each semester, students register and pay tuition in one primary school either at School of Law or School of Public Health. Over the course of the program, students register with School of Law for 5 semesters and with School Public Health for 3 semesters. Students typically register in School of Law for the first year of study and then register at Pitt Public Health for the second year. Each semester, students are eligible to take courses and fulfill program requirements in both schools, regardless of the school in which they are registered.

Students enrolled in the JD/MPH program save one full year of time and tuition versus completing the degrees separately.

#### **Credit Hours**

Pitt Public Health requires the completion of 45 credits to receive a Master of Public Health (MPH) degree, including 42 hours of required courses and 3 elective credits. Joint degree students may cross-count up to 8 hours of law school credits towards the MPH. The School of Law requires 88 credits for the Juris Doctor degree. Of these, 12 credits may be cross counted from Pitt Public Health.

Overall, the JD/MPH program requires 118 credit hours, which is 15 fewer than completing the programs separately.

#### **Specific Course Requirements**

In most cases, cross-counted law school credits can only apply towards electives. However, various courses from School of Law that fulfill the Upper-Level Legal Writing requirement can be used in place of HPM 2037 (Essay course). Joint degree students may fulfill the essay requirement for the MPH degree by completing this course for an approved topic and with appropriate (formatting) modifications for the MPH essay. The final essay must be submitted via D-Scholarship.

  - IMPORTANT: The ULW course satisfies HPM 2037 (Essay-PH) for the MPH, with appropriate modifications. (It must be completed in Year 3.)

#### Overview of Core Curriculum

The core curriculum provides the foundational knowledge and competencies that all public health professionals need. Based on the CEPH Core Competencies, the core curriculum covers the following broad areas:

- Epidemiology
- Biostatistics
- Environmental and occupational health
- Behavioral and community health sciences
- Health policy and management
- Public health biology
- Public health professionalism
- Systems thinking
- Program planning
- Communication and informatics
- Diversity and culture in public health practice
- Leadership

#### Goals of the core curriculum enable graduates to:

- Command the essential competencies of public health's core content areas and apply those competencies to complex public health issues.
- Explain how their chosen public health concentration contributes uniquely to the study of population health, and how it intersects with other public health disciplines.
- Articulate and advocate the values and ethics that distinguish public health as a historic, contemporary, and cohesive field of practice and inquiry.

- Successfully plan and execute programs and/or research intended to advance the public's health and health awareness, nationally and globally.
- Communicate effectively and appropriately with diverse groups of professional colleagues and public constituents.
- Locate, assemble, and critically analyze data, information, and knowledge resources.
- Develop a sense of identity, authority, and service in public health, and within their elected area of specialization.
- Assume key management roles in health organizations, and provide leadership in creating, implementing, and interpreting policy that promotes the ideals of public health.

#### **Policy on Required Core Courses**

Students pursuing an MPH must take all of the school-wide core courses unless their program has been granted a waiver of certain courses.

#### **PUBHLT 2035 Applications in Public Health Policy**

All new students are to complete the Pitt Public Health core courses in a sequence that will prepare them to meet the prerequisites of the Applications (PUBHLT 2035) course. Students should enroll in the Applications course once they have completed all of the Pitt Public Health core courses (prerequisites for PUBHLT 2035) or if they are simultaneously enrolled in one other core course and the Applications course.

#### **Course Exemption for PITT Public Health Core Courses\***

Exemptions from school-level required courses are made on a case-by-case basis. These are based on attainment of CEPH competencies through coursework and completion of course(s) at an accredited school of public health. These courses may or may not be accompanied by advanced standing credits. More information on this policy can be found in the <a href="Course Requirements">Course Requirements</a> section of the <a href="Pitt Public Health Academic Handbook">Pitt Public Health Academic Handbook</a>.

\*There is never a reduction or waiver of the total number of credits required for graduation (60 MHA, 45 MPH, 73 MHA/MBA, 118 JD/MPH) — required course credits are replaced with other elective credits.

#### **POLICIES AND PROCEDURES**

#### Pitt Public Health Academic Handbook

#### Course Registration and Enrollment

Registration for each term must be done with the advice of the student's academic advisor who is also required to sign off on all <a href="mailto:enrollment forms">enrollment forms</a> prior to the posted registration deadlines. Class schedules are available at <a href="https://www.publichealth.pitt.edu/academics/courses-schedules-enrollment">https://www.publichealth.pitt.edu/academics/courses-schedules-enrollment</a>. Once completed and signed, students should return their enrollment form to the program coordinator (<a href="mailto:jessdornin@pitt.edu">jessdornin@pitt.edu</a>) so the advising hold can be removed. Students can register for courses through PeopleSoft only after their advising hold has been removed. Some courses will require permission for enrollment given by the faculty member/department who sponsors the course. Students must request a permission number, when necessary, in order to enroll in the course. If you are seeking information about courses, permission numbers, faculty, or other opportunities, please refer to the listing of departmental student services staff available at <a href="https://www.sph.pitt.edu/admissions-aid/contact-admissions">https://www.sph.pitt.edu/admissions-aid/contact-admissions</a>.

Please note that a student can add or drop classes without penalty until the add/drop deadline. Registration, add/drop, monitored withdrawal, and other important dates can be found on Pitt's Academic Calendar.

#### **Grade Requirements**

A grade of B or better is required for all core courses. If a student earns a grade below a B, they should meet with their advisor to discuss the grade. In these cases, the student is strongly encouraged to re-take the course. However, the final decision will be left to the advisor and the student. If a student earns a grade below a C, they must repeat the course. The Educational Policy and Curriculum Committee (EPCC), via the Office of Student Affairs, will email a memorandum notifying the student and their advisor of the policy. Students have a maximum of two attempts to achieve a grade of C or better in a core course.

#### Essays

#### MHA & MPH Essay Committee structure:

- •The committee must consist of at least two University of Pittsburgh faculty members.
- •Members must have primary appointments in different University departments (at least two departments represented).
- For HPM, the Primary Essay Advisor must be a core faculty member in HPM. The second reader must be a member of the core faculty in another department within the University of Pittsburgh. For MHA students, a third reader is required who is a practitioner in the field.

Foreign students completing summer residencies, practica, or internships must complete a "Curricular Practical Training Academic Verification" form must be submitted to OIS prior to the start of the summer experience, as OIS must approve the practical training BEFORE it begins. Students complete the form online and print a copy for the program coordinator.

Both the MHA and MPH Programs are professional preparation programs of graduate education. Accordingly, professional (business) dress and conduct is expected as the norm. #### Student Study Areas

The department has a designated student study area on the 6th floor, 6121C, that is shared with BCHS students. Please note, the computers in this space are only available to BCHS GSR students. Email the program coordinator for the room code as this room is locked. Additional space is available on the fourth floor, 4121C. A student conference room, which is shared by all students in the department, is available in A663. This room must be reserved prior to use.

### Time Required to Complete Program of Study/ Statute of Limitations

The typical full-time MHA and MPH student will be able to complete their course of study in two years (five academic terms), including a full-time field placement in the Summer Term. Full-time MHA students will typically register for 15-16 credits per term to complete the required 60 credits within two academic years. Full-time MHA/MBA students will typically register for 12-15 credits per term to complete the program within three years (MHA/MBA's may register for up to 18 credits a term). MPH students will register for 11-12 credits per term in order to complete the required 45 credits in two years. However, the MPH students may register for up to 16 credits per term for the same block tuition rate. This will allow the MPH student to fulfill one of the SPH Certificate Programs or complete additional electives with few or no overload credits. JD/MPH students typically register for 13-15 credits a term to complete the program within four years. Please note, when registered in the School of Public Health, you may only register for up to 15 credits a term.

The statute of limitations for completing the professional Master's degree (MPH and MHA) is five years. However, students may request an extension to the Department Chair in writing with due justification provided.

#### **University Counseling Center**
